

Terms of reproducing or reusing articles published in the Journal of the Physical Society of Japan (JPSJ)

Established on July 22, 2005, effective October 2005
and Revised in October 2006

Condition A: In any format (printed or electronic), no modification allowed, including to copyright marks. Complete reference should be given when partially quoted.

Condition B: To be linked to a JPSJ web page of the relevant article when in electronic format.

Condition C: Only one-to-one transmission to a single recipient at a time. Simultaneous transmission to multiple recipients, including mailing list(s), is disallowed.

Condition D: The author's consent is required.

Condition E: Loading a PDF file or electric copy of the printed paper onto the server is not permitted. When loading the article onto the server, the approval of the co-author(s) is required.

Remarks

1. A research project (or project team) composed of members from multiple organizations is regarded as a case of the employer.

2. The CD-ROM format and microfilm are treated under the same terms as for printed paper.

3. The 'PDF file' in the Medium column includes PDF files having appeared on the JPSJ web page and any other PDF (and other electronic) format.

4. When reprinting part(s) of article such as figures and tables, which include citation or citation information, complete citation information shall be included.

5. Even if the article is the author's final version, release shall be after publication of the electric form or printed paper thereof.

6. Any article which is approved for reproduction/reuse shall be used in deference to copyrights belonging to the (co-)author and the Physical Society of Japan. Further, administration of any article loaded onto the web server is required.

7. Notification of a URL should be sent to pubstaff2@jps.or.jp by the applicant for approval.

8. The Terms shall apply to any and articles used after October 1, 2006.
